As I write this looking out over the lake I try to imagine if it's the same view that the original CLA President had back in 1932. I read through the original articles and try to take in the original principals the CLA was created for. After 77 years things change but the core values remain. It's back to basics for the CLA.

Not everyone knows all the things the CLA does. We pay for and monitor the police boat coverage, pay for and complete the Bill Willemin memorial

goose roundup, pay for and coordinate the fireworks which are shot off the CLA owned and maintained barges, review fish stocking, keep our members informed of local legal happenings, maintain an information website and new online forum. We send out newsletters and pay for water quality testing as well as completing basic water testing.

There are several new concerns on the list this year. Safety issues due to overcrowding on the lake. We have contacted the

DNR about manning the launch site which would limit outside boaters once 46 are put in. We have been active monitoring the road-end issues and have suggested possible resolutions. By far the number one concern of our membership is the proposed change to Township Ordinance 15A. The new online forum has rave reviews and is a place for everyone to communicate and express their opinions.

I am truly honored to be elected your CLA president and feel fortunate to have such an active board.

2009 Fireworks by Mike Dyer

The most visible project your CLA provides each year is the July 4th firework display. The feedback from this years' show was overwhelmingly positive.

We've been using the same display company, "Night Magic" for a number of years with consistently professional teams helping Crystal celebrate our nations' Independence Day. There are very few display companies that have the ability to fire a waterborne show such as ours. The budget for this years' show was \$8,500.

Our plan for the 2010 show is tentatively set for Sunday, July 4 at 10:30 pm. Historically, the CLA has consistently chosen to

provide the fireworks on July 4 regardless of what day it falls. We certainly are open to member thoughts and invite any comments from our membership.

Also, we are looking for donations for our fireworks "barge". You may not know that the fireworks are fired from a barge made of four pontoon boats that have been stripped bare to the frame then decked with treated plywood. As these boats are stored outside year round and take a considerable amount of stress for 20 minutes each July 4th, they require regular maintenance. If you or anyone you know has

any large scrap 3/4" pressure treated plywood and would be willing to donate it for the barge repairs your CLA would be most grateful. Or, if you or someone you know has an old 20 to 24 foot pontoon with good tubes and a solid frame, we are always looking to add to the barges. We certainly would be happy to haul it away for you.

Township Ordinance 15 by Bonnie Kanitz

Get the word out!

Just say NO to changing Ordinance 15A. The changes being considered by the Crystal Township Board reverse anti-funneling controls and have the potential to create overcrowding on the lake *and* on the lot next door to you! Overuse of Crystal Lake can negatively impact property values as safety, health; sanitation and ecological quality of our lake take a downturn. .

A township hearing was held on August 13th and approximately 40 people were present to voice concerns and ask why the ordinance needed to be changed. The township gave the following reasons for the proposed change; 1) it is hard to understand or interpret the current ordinance as worded 2) Crystal Lake is primary

to the economic expansion of Crystal Township and increased traffic is desired to support local business, 3) The previous township board made exceptions outside the ordinance which could subject the current board to a lawsuit.

Seventeen people present at the meeting signed up to work with the township.

A meeting was held August 20th and again a very lively discussion on both sides ensued. .

The proposed change allows up to 7 parcels/lots access for each 50 feet of lakefront. This pro-funneling amendment reverses Ordinance 15A's intent to control future funneling developments. Most Michigan lakes are now covered by anti-funneling ordinance. To learn more, please go to www.miswa.org.

The CLA Board unanimously agrees to disagree with the township board. Several legal opinions and advice have been sought on action that the CLA can take.

A volunteer committee was established to develop a plan of action. Members are John Beck, Bill & Sharon Hepburn, Bonnie Kanitz, Pam Tabor, and Bill Tomlin. The committee will monitor regular township meetings and special meetings. Updates will be posted on www.crystalonline.org/forum

Summer Survey of Crystal Lake by Bill Tomlin

The summer lake water survey of Crystal Lake took place in July 2009. Stephen F Kasa, Lab Manager and Project Manager of Applied Analytical Labs, of Grand Rapids took the various samplings.

An extra sampling for Ecoli (fecal coliform bacteria) was taken at South Shore Campgrounds as a possible case of ecoli was reported. **No** fecal

coliform bacterium was detected. It was determined that the reported case was nonrelated.

The following tests were taken, Temperature and Dissolved Oxygen as well as Transparency in the central basin. Also evaluated were Nutrient data, Conductivity, pH data, Fecal Coliform, as well as identification of common Planktons.

The report was submitted

to the CLA with a discussion of a water quality analysis as were Stephen F Kasa's, Notes and Conclusions. According to Mr. Kasa, the final results of the Crystal Lake water quality testing summary, is the **"Crystal Lake remains very healthy during the sampling event and the analytical results confirm this."**

A safer answer to all the people traffic is to construct a Bike-Walk Path"

Bike-Walk Path Project

On a year-round basis many hundreds of adults and children like to go the 5 mile around the lake. All ages like to walk, bike, stroll, jog, run and rollerblade "round-the-lake". The roads on the East, North, and West sides of the lake have a 25 or 30 mph speed limit. So people traffic is relatively safe.

However on the South side of the travel route, the short stretch of Sidney Road has a hazardous 55 mph speed limit. Many efforts to get the speed limit lowered have failed.

A safer answer to all the people traffic on that part of the "round-the-lake tour" is to construct a Bike-Walk Path on the North side of Sidney road, well within the existing 66 foot road right of way.

The Montcalm County Road Commission estimates that the cost to build an 8 foot path along Sidney Road is \$25,000. Using the estimate at hand, the Crystal Township Board has set aside \$12,500 in a dedicated fund for this purpose. Another \$12,500 is needed in
