Prominent Township Items

Last July, two duly elected Township Trustees (Diane Rydahl & Roger Martin) resigned from the five member Board. Both had been minority votes in several Township issues over time. Their resignations followed after the Board voted down hiring a specific outside contractor to develop and maintain the Township's long defunct website. Town Supervisor Curt McCracken later told the Daily News that the Board voted down the motion to look for cheaper options. Bottom line, the majority and minority views expressed by the Township Board over time had been sharply divided.

By the September monthly meeting, the Township Board having followed long established protocol, had six volunteer applicants to fill the two vacancies until the next regular election. Two of this six were were selected unanimously by the remaining quorum of three.

Alyssa Little, a 1 ½ year Township resident living on Mt. Hope Road, who has a degree in Business & Accounting, and who is employed by Huntington Bank.

Sarah Daily, a 4yr resident living on Strait Tow Blvd, who has a degree in Social Studies, and who, with her spouse John Daily, are former business owners. The Daily Family have been rooted in Crystal since the 1930's.

The three other Board members include Crystal Township Supervisor Curt McCracken, Township Clerk Pat Marek, and Township Treasurer Nancy Johnson.

At the aforementioned September (2022) regular monthly meeting the Board announced that the Township had launched a basic interactive website. This site can be accessed at crystal-township. com, and contains basic Township information including links to elections-voting, Assessing, Cemetery, meeting minutes, and other contact information.

Also of note, Crystal resident John Daily voluntarily records all Crystal Township regular and special Township meetings in the YouTube format and disseminates to the Crystal Comes Together and Crystal Township Michigan group sites. The CLA Facebook page regularly posts the recorded meetings. Thank you John Daily for this great public service for all residents of Crystal Township.

Crystal Park Renewal Project: Wolverine (General Contractor for Park renovation) reported in February, 2023, that the Park project was fully prepared to go out to bid but were waiting for the Michigan DNR (EGLE) to officially sign off. As the primary grantor, DNR has the final approval for everything. Wolverine predicted that the project would officially begin this Spring (2023), mainly on the South end. Major work totally impacting the Park would be suspended for Summer 2023, so as not to interfere with public use in the high season. Work will resume in Autumn. The project will be completed and be available for public use by Summer, 2024. Wolverine also reported that construction costs had been impacted by inflation and Covid over the past five years that the project has been pending consideration. Originally, costs were in the \$525,000 to \$550,000 range. Today (not tomorrow) costs had escalated to roughly \$760,000.

On March 22, 2023, the Township Board held a Special Meeting for the limited purpose of three matters: a) Closing the open window for marijuana licensing and approving the transfer of the Adult license issued to Twisted Sista on Main Street to a new owner; b) Road fixes for the 2023 repair season; and c) hearing a presentation by David Wight, Chairman of the Crystal DDA, in his capacity as a private citizen, propose projects for the community which would tie into the ongoing Park redevelopment. Projects delineated included restrooms, pavilions, additional parking, a Welcome Center, etc. The costs for his proposal exceeded \$500,000 and clearly would add much benefit to the facelift envisioned for the Crystal Lake waterfront. The Board reacted in a very limited way because funding for a project such as described is not available on the Township Balance Sheet and opportunities for State grant monies are elusive at best. The details of David Wight's presentation were reported in detail in the March 27th issue of the Daily News.



Recycling: Crystal is in line for a recycling equipment conversion from the existing bin system to a state of the art compactor. Most of the costs will be underwritten by Montcalm County. An up to \$5000 contribution from the Township will be required and include an appropriate concrete slab and upgraded power sourcing equipment. The new system (months away, perhaps even into 2024) is likely to be relocated to the Fire House area.

Police Coverage: At the regular monthly Township Board meeting in February, the Carson City Police Chief made a presentation in support of his department taking over the police coverage contract for Crystal Township currently with Sheriff Mike Williams, Montcalm County, supported by the Township police milage. Township Supervisor Curt McCracken recently commented that there has been little to no traction for the proposal, and that Sheriff Williams intends to fulfill the existing coverage contract.

Other Formerly Prominent Items:

Community Center – Essentially snoozing except for unanticipated roof repairs to fix the roof fix over the oldest section of the old school.

Go Cart Property – Grant funding not available.

Wind & Solar Considerations – Not on Crystal Township radar.

American Rescue Plan Act of 2021 (ARPA) – Some ARPA funds were spent to enhance equipment for Crystal Fire, construct a South Pier Park pavilion, etc. However, a substantial nest egg remains as insurance to cover costs for the Park Redevelopment Project.


Potential Crystal Sewer Extension – The Township Board considered a request to complete the circumnavigation of the sewer system in conjunction with available ARPA funds. Following research and due diligence inquiries, the Township declined to earmark monies for this purpose.

Your membership every year supports all the activities the CLA undertakes in order to keep Crystal Lake the place where so many of us want to spend our time. The CLA cannot function without you, our members. While your \$45 annual fee supports many activities, you also have the option of supporting other specific activities. Two in particular I would like to mention are Water Quality and Fireworks. Water Quality is arguably the most important work we do yet it annually receives the fewest funds from members. Water Quality Report

This past September we decided to have a late summer survey for invasive weeds. The survey was completed on September 11. We found sparse A/B level Eurasian Water Milfoil @ 4.64 acres and C/D level EWM @ .36 acres. It was obvious where the previous EWM was treated as we pulled up samples-the treatment did appear to be effective, however new growth is showing at lighter levels.

Treatment was completed on September 22nd. We would hope that it will result in less milfoil when we survey later this spring.

Secchi Disc (water clarity)

Our water clarity readings were very good this past summer, however they may be attributable to invasive zebra and quagga mussels which filter the water. It was noticeable that the water was clearer than the prior year.


Phosphorous

A key nutrient of algae phosphorous. Some phosphorous is necessary to support the food chain for fish. Too much and we have algae. It's naturally occurring, but also comes from fertilizers in runoff from lawns and farm fields. Since we have a sewer system, leaking septic tanks are not a problem. Cottage owners should keep lawn fertilizers well away from the shoreline. The graph below indicates that we have an upward trend.

Chlorophyll

Consistent with our Secchi disc readings, chlorophyll readings were very low last summer. Less algae leads to clearer water - probably zebra and quagga mussels at work.

Chlorophyll:



Last summer Jim Ayres started participating in Secchi disc measurements and water sampling for chlorophyll and phosphorous. This spring he's taking phosphorous samples. The reports above are the results of our samples. Jim has a background in biology and has been eager to take over water quality from me as I have decided to not to re-up as a board member after the July general meeting.

Water quality has become the largest expense in our budget. We've done a good job keeping Eurasian water milfoil under control, but it is expensive. Surveying the lake to find the invasive weeds and subsequent treatment can cost \$12,000-\$20,000 each time and we are surveying twice, spring and late summer. Some lakes have let it go and find they are faced with six figure cost. We very much want to avoid that and keep our lake from being choked by milfoil. We can't take a clean lake for granted. If you like to swim, fish, boat or keep the property value of your cottage up, we need a clean lake.



Fourth of July Fireworks:

Goose Maintenance Program - Eric Johnson

Goose season is upon us. The lake is clear of ice and The Geese are starting to reappear. We need to prepare for the upcoming "Goose Maintenance Season". Permit requests have been sent and we are waiting for final approval and dates. In the meantime, please scout the areas around your property and adjoining properties and report the location of any nesting couples you observe. We have been informed that the "Goose Roundup" will not be allowed again this year due to Avian Flu concerns, so the Nest and Egg maintenance will be our only shot at controlling the number of geese on the lake. If all of the geese that were on the lake last year return as nesting pairs, we will have a huge population growth this year.

Please take time to scout the areas around your property. When you locate a nesting pair, flag the nest location and if possible geolocate it so that our trained "Nest Maintenance Personnel" can properly monitor the nest and determine the appropriate way to take care of it. If you are not trained, please do not disturb the nest yourself. If you are interested in being trained, please contact me via email at the address below.
