Along with all the excitement of summer coming, there will also be docks and boats going in and lots of traffic on the streets around the lake. Let's do the best we can to be mindful of the walkers, joggers and cyclists as you travel our surroundings as they are a very important part of this precious lake life.

As mentioned in earlier online posts, the Crystal Township Community Center has taken on a new and improved look. The township officials chose to construct a new roof over the north east portion of the center. It has been in need of repair for quite some time and it has definitely added a newer, cleaner look to the building. Kudos for the township for making these much needed repairs and overall investment in the center.

As reported in local newspapers, there has been significant concern regarding the future of police patrol in Crystal Township by the Montcalm County Sheriff's Dept. It was recently brought to the township's attention, the lack of personnel to accommodate patrolling in our community.

Apparently the sheriff's office has been plagued with a high turnover rate of officers, in addition to having difficulty hiring new personnel to fill those positions. As Sheriff Mike Williams struggles with these departures, the sheriff's patrolling contract with Crystal Township and other surrounding townships is in jeopardy of being eliminated by him as a result. The question remains whether or not he has the authority to do that, according to county commissioners, based on the contract verbiages. As Sheriff Williams is doing all he can to accommodate a realistic solution, he has agreed to maintain patrolling in Crystal Township at 30 hours a week, down from the contract base of 40 hours. Keep updated on this issue with information from The Daily News as this involves mileages recently passed to accommodate continued police patrol of Crystal Township. In other news, the Crystal Parks and Rec is writing a grant to the Michigan DNR in an effort to receive \$150,000 towards planting trees and beautifying in and around the parks and downtown areas of Crystal Township. The Parks and Rec has asked the CLA to help support this effort, which was unanimously agreed upon!! This grant does not require any matching monies or additional labor. Let's keep our fingers crossed that we are awarded this grant. What a way to put more frosting on the cake here in our developing community.

## **Fireworks Update**

## **Lake Update - Spring 2025** *Jim Ayres*

For 2025 we have contracted with a new provider, Progressive Companies, for our lake assessments and treatment management. Progressive offers us several improvements in service over our past provider. These include:

- Conduct monthly lake surveys in May, June, July, and August. We have traditionally had 1-2 surveys per season. The more frequent surveys will increase our protection against invasive species damage.
- Perform post-treatment inspections to ensure treatment quality.
- Employ the use of drones as needed to enhance lake assessments.
- Coordinate plant control activities through a website portal to ensure work proceeds in

- a timely, environmentally sound, and cost effective manner.
- In addition, a Senior Biologist from Progressive will attend a Lake Association meeting to present a summary report reviewing results with recommendations for future lake management.

Work will begin soon, with the first lake survey scheduled for May 14, pending the weather. As our Progressive representative, Rick, told me recently, "we finally got a real winter". No promises, but that may have some effect on reducing plant growth compared to prior years. We will keep you posted!

## **Goose Maintenance Update - Spring 2025** *Eric Johnson*

By the time you read this newsletter, the 2025 Goose Maintenance season will be pretty much over. We have our "Nest and Egg Maintenance" permit for 2025, and have a dedicated group of area captains surveying different zones of the lake. I am hopeful that we will have a successful season. We do need to be aware that, most likely, we will see a growing population of geese on the lake. This is due, primarily to the fact that the old system of Goose management relocated young and old from the lake. Our current program removes just some of the young. We will likely see a growing number of Geese returning to our lake. Whether we adopt more aggressive methods in the future will be primarily up to the CLA Board, the CLA members and the Township Board. If you are interested, there is a lot of information on the Michigan DNR site. (https://www.michigan.gov/ dnr ). Just search "Canada Goose" and you will find a plethora of information. Not only can you learn about controlling the Goose population, but ways to manage your interaction with the Geese.

In the meantime, there are ways you can help us over the summer to prepare for a successful 2026 season.

- Be vigilant around your cottages and note any spots that you observe nesting potential. Geolocate or just mark it on a map and get the information to me. We will use this information next year.
- 2. Stop by the lake in early spring and take a walk around your area and note any evidence of nesting geese.
- 3. Encourage your neighbors to do the same.
- 4. If you haven't already, join the CLA and encourage your neighbors to do the same.
- 5. Give us permission to canvas your property in your absence. (a letter, text or email sent to us is sufficient).
